Roles and Responsibilities:

- 6. The committee should submit the monthly report regarding the problems/ issues of concerned staff/ students/ faculty regarding any matters which may hamper the self-esteem of the SC and ST students and staffs.

Hence, for any deviation, Convener, coconvener and all the members will held the responsibility and the higher authority will have every right to take necessary action as deemed fit.
